RESPONSIBILITY FOR RECORDS

According to the *N-DEX System Policy and Operating Manual Version 4.0*, the records in the ROA record/case management system are considered the source records. ROAs that make records available in the N-DEX System are responsible for the following:

- **TIMELINESS** Updates or changes to the original submission shall be executed at least monthly.
- **ACCURACY** Contributed data is synchronized with the agencies source system records as they are updated/changed.
- **COMPLETENESS** Submit as many N-DEX data elements as available or are permitted to by law.
- **POC INFORMATION** 24-hour generic agency POC phone number and email (if available).
- **VERIFICATION & USE AUTHORIZATION** Ensure agency POC is able to respond to verification and use authorization requests from the N-DEX System users regarding the agency's records.

DATA SHARING

Each ROA controls how and with whom their data is shared, thus retaining responsibility, control, and ownership. The N-DEX System is designed to allow ROAs to protect their data in accordance with the laws and policies that govern dissemination and privacy for their jurisdictions. **All data is presumed sharable, unless the ROA restricts data access**, in accordance with their sharing policy. The N-DEX System enables data sharing at the following dissemination criteria values:

- **GREEN** Data is viewable. ALL records within the N-DEX System are defaulted as viewable to ALL users.
- **YELLOW** Data consists of record ID and ROA POC information. To obtain access, contact the ROA.
- **RED** Data is not viewable.

ROAs are encouraged to submit records using the "Green" value to realize the full benefit of automatic entity integration, data correlation, and other tools within the N-DEX System, including the creation of subscriptions.

Will the submitting agency and ALL the ROAs share data using the "Green" value? If not, the submitting agency will be provided with the *N-DEX System Data Sharing Form*.
